CONCLUSIONS BY COJEP INTERNATIONAL

Here are our conclusions after these two days spent in New York :

- 1. Thank to our participation to the 67th conference of the NGOs in New York, we had the opportunity to see that the most important committees and decisions made were in New York. The United Nations in Geneva is only an agency of the chair which is in New York. We also discovered that relations between the NGOs and the United Nations are very different in New York and in Geneva. Indeed, in New York, NGOs have a more diversified field of action.
- 2. The 67th conference of NGOs in New York gathered 2 000 people, from NGOs of all over the world. It was a unic occasion to find new partners to work with for our projects. For the first time, we had the possibility to carry our revendications in New York.
- 3. We attended several workshops during the 67th conference of NGOs in New York. We noticed that there were only a limited number of NGOs from the muslim world. The majority of NGOs were american or chinese. It is necessary to multiply our works in New York.
- 4. We had the occasion to distribute our leaflets about our new project, « Reforming to reform the world » about the UN Security Council.
- 5. We learned by the turkish delegation that it was possible to organize conferences in September during the session of the UN general assembly. However, it is only possible with the help of a major political personality. The permanent turkish delegation of the United Nations in New York advised us to ask Mrs. Emine Erdogan for help in order to allow us to organize a conference in September 2019 on the theme of our new project. reform to reform the world, about the reform of the UN Security Council. It is essential for us to begin the preparation works for this conference with the help of YTB.
- 6. The turkish delegation adivised us to attend each year the workshops in New York in order to remain activ in the different committees and to develop our influence in New York :
 - At the sessions of the General Assembly in September
 - At the conferences of UNDPI/NGO, these are the conferences which we attended in August 22 and 23, 2018. They take place every 2 or 3 years.
 - At the committees of UN WOMEN. UN WOMEN help in the participation of NGOs at the sessions of the CSW (Commission on the Status of Women). The NGOs which are NGOs accredited to the United Nations Economic and Social Council (ECOSOC) and having a good reputation with them can nominate representatives to attend the annual sessions of the CSW.
 - At the sessions of the Commission of social development. The Commission is the advisory body responsible for the pillar of global social development. This year, the CSocD56 concluded with the adoption of measures by government officials and civil society leaders, including the creation of social protection systems, which would help the millions of people still poor, especially those who are vulnerable.
